   OR
- (2) The family is currently receiving FULL grant from <u>School Textbook Scheme</u> from Student Finance Office. OR
- (3) Those students whose family are encountering financial difficulties. (Note: Information explaining the family's financial situation and meeting the conditions for the evaluation of financial difficulties is required and will be considered.)

Eligible students will receive either FULL grant or PARTIAL grant when they participate in Life-wide Learning activities. To comply with school policies regarding Student Activities Support Grant, personal information of students has to be collected. Please fill in the reply slip below and submit copies of valid supporting documents. The school will contact parents for verification of the application eligibility of students when necessary. The school will not use the information for other purposes without parent approval and will ensure information confidentiality to protect privacy. In case of any changes of family financial conditions causing the student to become eligible for the Grant during the school term, please contact Ms. CHU Wai Chun (2728 7627) and submit copies of relevant document proof to your child(ren)'s Class Teacher or Ms. Fung, staff in school office, so that your case can be handled.
