## **Application for Student Grant (2023/24)**

Please note the following arrangements for Student Grant for day school students in the 2023/24 school year.

#### **Application Arrangements**

1. Starting from the 2023/24 school year, parents / guardians (i.e. applicants) may submit online applications for the student grant for students studying in public sector schools and Direct Subsidy Scheme (DSS) schools. Applicants must have a user account of "iAM Smart+" with **digital signing function**. They may log in to the online service of "e-Submission of Student Grant Applications" via the "iAM Smart" App direct, or scan the QR Code below or click the link below to log in to the e-submission platform to submit online application.

- 2. For details of registration of "iAM Smart" App, applicants can visit the website <a href="https://www.iamsmart.gov.hk">https://www.iamsmart.gov.hk</a>.
- 3. Applicants must read the "Application Instructions" carefully on the electronic platform. Applicants who successfully applied for Student Grant in the 2022/23 school year are "continuing applicants". "Continuing applicants" can obtain a pre-filled electronic form after successfully verifying their identity with a one-time verification code and they just need to check the relevant information of students and the applicants on the pre-filled form and fill in the student's class, the electronic application can be submitted through digital signing. If necessary, continuing applicants can modify the information on the electronic form.
- 4. If the student is a new student or has transferred to another school, the "continuing applicant" must select the new day school name in the electronic form.
- 5. Before submitting the application, the applicant must verify that all information is correct, especially the school name, so as not to affect the application progress due to incorrect information. The following is our school name and school number for reference.

- 7. The Education Bureau (EDB) will notify applicants of the application progress and related matters via SMS and / or email. Applicants can also check the application progress and use other functions on the electronic platform. For example, at the request of the EDB, updating information on electronic platform update or modifying information, uploading supplementary documents, etc.
- 8. Paper application forms will be distributed in early October, details will be announced later. Students who submitted electronic applications last school year will not be issued paper forms. The school encourages parents to continue to use electronic applications.
- 9. Each eligible student can only submit one application through either electronically or on paper.
