### **Responses to Primary 1 to 5 Parents' Day Opinions Survey**

The school invited parents to conduct a questionnaire on Primary 1 to 5 Parents' Day on 13<sup>th</sup> January, 2024, which covers such aspects as "amount of homework", "choices of after-school interest classes", "moral education training programs" and "the communication arrangements between the school and parents". According to the data collected, more than 95% of parents strongly agree or agree with the school's management on above scopes of work. However, a small number of parents still have questions about the above arrangements. Therefore, we are now responding to those questions concerned:

#### **1. Quality and quantity of homework**

As a government primary school, our homework is not only arranged according to students' level and learning needs, but also designed in accordance with the guidelines of the Education Bureau. The homework arranged by our school emphasizes on quality but not mechanical drilling. It is neither excessive in quantity nor repetitive in nature. In addition to daily general workbooks and worksheets, homework types covering previews of chapters, learning logs, vocabulary review, recitation of good sentences, project works, interviews, speaking practices and online learning exercises are included as well. We also encourage students to make good use of self-study lessons at school to complete part of their homework. If students have completed their homework for the day before returning home, they can complete learning tasks on relevant self-learning websites or do extra-curricular reading to improve their self-learning abilities.

#### **2. Arrangements of after-school interest classes**

Different interest classes are planned for students' participation by considering the school's existing resources and student's interests and abilities at different levels. However, we cannot meet the needs of every student due to limited space and resources. Nevertheless, the school will strive to develop and make good use of school resources and we are looking forward to increasing the number of English classes, musical instrument classes and sports training classes in the future.

#### **3. Moral education training programs**

The school has always attached great importance to students' moral development. Therefore, besides incorporating moral education training into daily classroom learning, values education lessons are conducted weekly this academic year. Furthermore, students are nurtured with right values through daily morning assemblies and weekly meetings on different themes. The school has also implemented "I am Proud of You" Star Reward and Punishment Scheme to reward students for their good behaviour inside and outside school, and it is hoped that they can do much better in all aspects including conduct, academics, services and responsibility. The cultivation of students' moral education must be achieved through close home-school cooperation. Therefore, if parents encounter any problems disciplining your child(ren), please contact the class teacher or discipline master at any time.

#### 4. The communication channels between the school and parents

In addition, Parent-Teacher Association (PTA) serves as a bridge of communication between the school and parents. Parents can join the WeChat groups established earlier by the PTA at all levels in order to receive messages from the school and parents' questions can be answered more conveniently.
