Briefing Session on Central Allocation Arrangements and "School Selection in Central Allocation (CA)"

If your child(ren) has participated in the Discretionary Places (DP) Stage in the Secondary School Placement Allocation (SSPA), please be reminded that all participating secondary schools will notify parents of the successful participants of their children's inclusion in the Successful Lists for Discretionary Places (DP) <u>on</u> <u>27th March, 2024 (Wednesday)</u>. Parents who have registered as SSPA e-Platform users may also view notifications for successful DP applicants via the SSPA e-Platform starting from 10 a.m. on 27th March, 2024. Parents who have received notifications from participating secondary schools **DO NOT** need to reply to the notifications.

If parents who receive notifications from participating secondary schools have also successfully applied for a school place in a non-participating Direct Subsidy Scheme secondary school (NDSS secondary school) for your child(ren), and you decide to retain the DP offered by a public sector secondary school, you should notify the NDSS secondary school concerned and retrieve the signed "Parent's Undertaking" and the original of the "Primary 6 Student Record Form" <u>on or before 10th April, 2024 (Wednesday)</u> in order to retain the DP which you have successfully obtained. The retrieval of relevant documents will serve as confirmation that the parents concerned have surrendered the S1 school place previously offered by the NDSS secondary school.

To deepen parents and students' understanding of "Secondary School Places Allocation: Central Allocation", our school will hold a briefing session in the morning on <u>15th April, 2024 (Monday) between</u> <u>8:45am and 9:30am</u>, Details are as follows:

Besides, to facilitate parents who have not activated their SSPA e-Platform accounts, the Education Bureau (EDB) has extended the validity period of the "Activation Code" until late July 2024 (the "Activation Code" has already been distributed in November 2023). Parents who still want to use e-Platform for participating in the Central Allocation, please complete the registration before 30th March 2024.
